Dear Majority Leader Schumer, Speaker Pelosi, and Minority Leaders McConnell and McCarthy:

On behalf of the undersigned organizations, we write in strong support of the proposal included in the American Jobs Plan to invest \$30 billion over 4 years to better protect Americans from future pandemics. These funds can create new U.S. jobs in public health, science and technology innovation, and domestic medical countermeasures infrastructure.

Given the devastating consequences of the COVID-19 pandemic, the U.S. should aim to achieve an ambitious but achievable goal of creating a pandemic-free future. Therefore, we strongly encourage you to include this \$30 billion investment in a funding vehicle this year.

The COVID-19 pandemic has shown the national and international consequences that deadly infectious disease epidemics can cause. Over the past two decades, outbreaks of SARS, Ebola, influenza, Zika and others have cost the U.S. billions in lost productivity. The profound effects of this and other pandemics must galvanize the U.S. government to do everything in its power to prevent this from happening again.

In addition to naturally occurring threats, rapid advances in the biological sciences and an eroding norm against the development and use of biological weapons increase the chance that biotechnology could be used to create novel pathogens with the potential to start major epidemics or pandemics.

The next fast-moving, novel infectious disease pandemic could be right around the corner. The United States must be prepared to move faster when the next potential pandemic emerges to avoid catastrophic loss of life and economic disruption. A significant new investment in pandemic preparedness is vital to our country's economy and national security.

This new investment should support faster vaccine development and production, a more robust Strategic National Stockpile, increased research regarding possible disease threats, robust public health infrastructure and sequencing technologies, training personnel for epidemic and pandemic response, and related biopreparedness and biosecurity initiatives. The COVID-19 supplemental funds provided to date do not meet these longer-term needs. We urge Congress to provide \$30 billion over 4 years to protect Americans from future pandemics, before the next virus threatens the globe.

We thank you for your leadership on ending the COVID-19 pandemic and look forward to being strong partners with Congress on pandemic preparedness in the months and years ahead.
